**NUNC PRO TUNC TRADEMARK ASSIGNMENT**

THIS TRADEMARK ASSIGNMENT ("Assignment") Nunc Pro Tunc effective as of the 29th day of March, 1996, ("Effective Date"), by and between Former D-T, Inc. (formerly known as Design Trend, Inc.), an Ohio corporation, with is present office c/o CCP Industries, 670 Alpha Drive, Highland Heights, Ohio 44143 ("Assignor"), and Whitney-Corr-Pak International, Inc., (now known as Whitney Design, Inc.) a Delaware corporation, with a former office on March 29, 1996 at 19 East Kimberly Road, East Brunswick, New Jersey 08816 and its present principal office at 1920 Beltway Drive, St. Louis, Missouri 63114 ("Assignee").

**WHEREAS**, Assignor, Assignor's parent, The Tranzonic Companies, an Ohio corporation ("Tranzonic"), and Assignor's subsidiary, Every-Ready Appliance Mfg. Co., a Missouri corporation ("Ever-Ready", and collectively with Assignor and Tranzonic, the "Seller Parties") and Assignee have entered into that Asset Purchase Agreement, dated February 29, 1996 (the "Purchase Agreement"), pursuant to which the Seller Parties have agreed, *inter alia*, to cause Assignor to assign to Assignee certain assets relating to the intellectual property of Assignor's business, including without limitation that trademark registration identified and set forth on Schedule A attached hereto (the foregoing referred to herein as the "Mark"); and (c) the goodwill of the business associated with the Mark; and

**WHEREAS**, pursuant to the Purchase Agreement, Assignee wishes to acquire and Assignor wishes to assign its entire right, title and interest in and to the Mark, together with the goodwill of the business with which the Mark is used;
