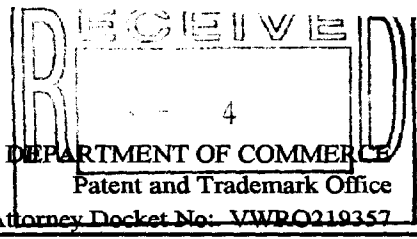


TRADEMARK ASSIGNMENT

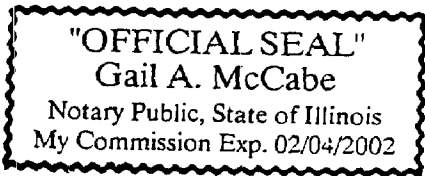
