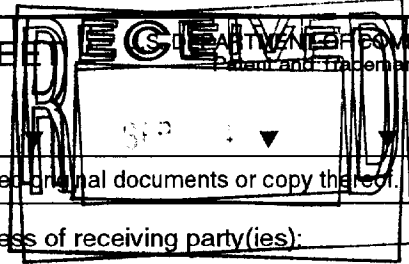

RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, BioStar, Inc., a Delaware corporation, located at 6655 Lookout Road, Boulder, Colorado 80301 ("BioStar"), and Silicon Valley Bank, California Corporation, 3003 Tasman Drive, Santa Clara, California 95054 ("Silicon"), entered into a certain security agreement (the "Security Agreement"), dated as of September 15, 1995, which was recorded on October 17, 1995 at Reel 1447 and Frame 0913, that by its terms granted Silicon a security interest in certain intellectual property listed in Exhibit C, all pending and registered trademarks, acquired or arising after the date of the Security Agreement (collectively, the "Trademarks");

WHEREAS, the Security Agreement provides that Silicon shall execute and deliver to BioStar a termination of all security interests granted by BioStar upon the payment and full performance of all obligations incurred under the Security Agreement; and

WHEREAS, BioStar has or has caused to be paid and satisfied in full the obligations for which the security interest in the Trademarks was granted.

NOW THEREFORE Silicon hereby releases its security interest in the Trademarks and reassigns to BioStar any interest in the Trademarks acquired by Silicon under the Security Agreement.
