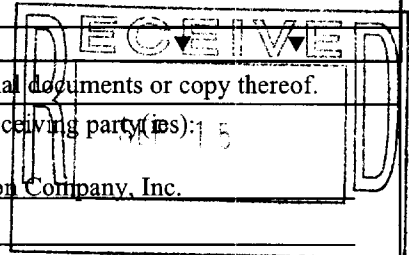

FSA COMBINATION CORP., a Delaware corporation (the "Corporation"), hereby certifies as follows:

1. The current name of the Corporation is "FSA Combination Corp." The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on August 12, 1996.

2. The Certificate of Incorporation of the Corporation is hereby amended by deleting, in its entirety, the current ARTICLE I thereof and inserting in place thereof a new ARTICLE I to read as follows.

"The name of the corporation is NA Combination Company, Inc. (herein sometimes referred to as the "Corporation")."

3. The Certificate of Amendment of the Certificate of Incorporation was duly adopted in accordance with Section 242 of the General Corporation Law of the State of Delaware.

IN WITNESS WHEREOF, the Corporation has caused this Certificate of Amendment of the Certificate of Incorporation to be signed as of the 26th day of May 1998, by William L. Larson, its President and Chief Executive Officer, and attested by Prabhat K. Goyal, its Chief Financial Officer and Secretary, who hereby affirm and acknowledge, under penalties of perjury, that this Certificate of Amendment is the act and deed of the Corporation and that the facts stated herein are true.

ARTICLE VII

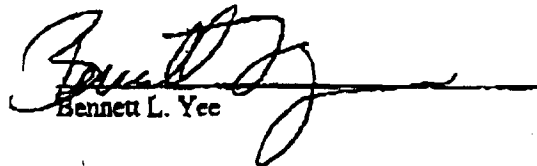
Meetings of stockholders may be held within or without the State of Delaware, as the Bylaws may provide. The books of the corporation may be kept (subject to any provision contained in the statutes) outside the State of Delaware at such place or places as may be designated from time to time by the Board of Directors or in the Bylaws of the corporation.

ARTICLE VIII

A director of the corporation shall not be personally liable to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except for liability (i) for any breach of the director's duty of loyalty to the corporation or its stockholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 174 of the Delaware General Corporation Law, or (iv) for any transaction from which the director derived any improper personal benefit. If the Delaware General Corporation Law is amended after approval by the stockholders of this Article to authorize corporation action further eliminating or limiting the personal liability of directors then the liability of a director of the corporation shall be eliminated or limited to the fullest extent permitted by the Delaware General Corporation Law as so amended.

Any repeal or modification of the foregoing provisions of this Article VIII by the stockholders of the corporation shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.

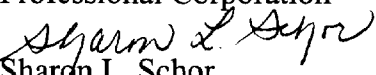
