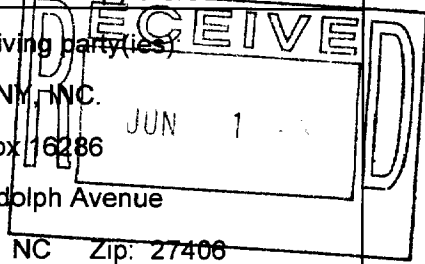

- d. any and all common law rights which Assignor has or may have in or to any of the Trademarks.

This assignment shall be effective as of December 30, 1997, *nunc pro tunc*.
