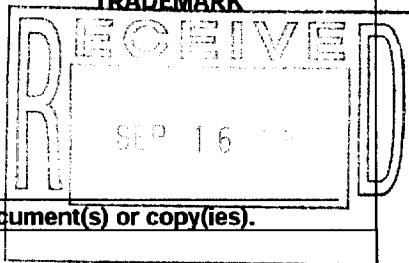

**RELEASE OF INTELLECTUAL PROPERTY
SECURITY AGREEMENT**

WHEREAS, The Hong Kong and Shanghai Banking Corporation, Limited ("HSB"), an Illinois chartered corporation having a place of business at 190 South LaSalle Street, Suite 1100, Chicago, Illinois 60603 does hereby acknowledge that it was the secured party under a certain Security Agreement executed by International Components Corporation ("ICC"), an Illinois corporation, having its principal place of business at 430 North May Street, Chicago, Illinois 60622, and HSB dated December 23, 1993 (the "Security Agreement").
