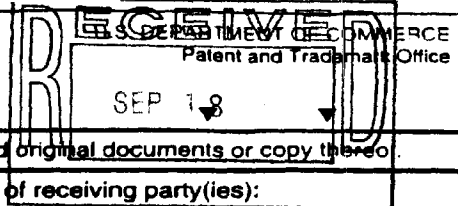

b. The foregoing amendment to the Articles of Incorporation was duly adopted on the 30th day of November, 19 94. The amendment: (check one of the following)
