

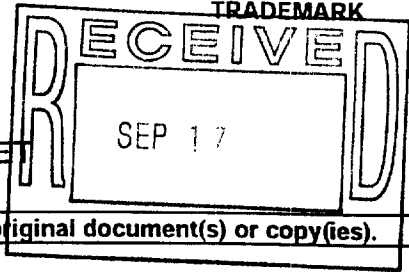

**FIRST.** The name of the Partnership is **SOFTBANK Forums L.P.**


**SECOND.** The Partnership's Certificate of Limited Partnership was originally filed in the Office of the Secretary of State on October 17, 1994.
