ASSIGNOR retains no ownership rights in the trademarks, trademark registrations and trademark applications transferred to ASSIGNEE by this assignment.

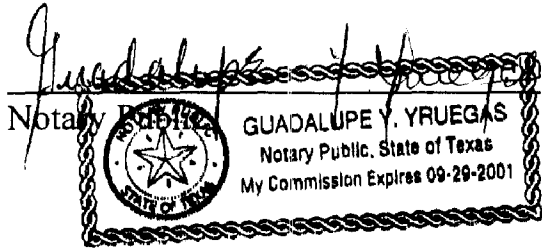
