
WHEREAS, Assignor has transferred to the Surviving Corporation all of its business to which the Trademarks pertain;

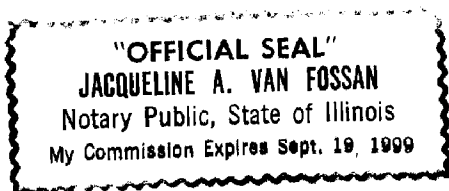
