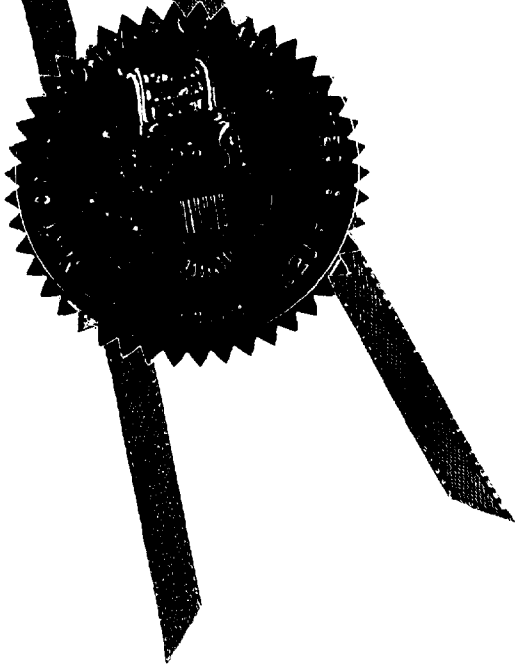

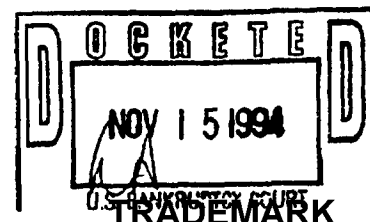

AMENDED ORDER AUTHORIZING SALE OF DEBTORS' TRADEMARKS

UPON the application (the "Application") of Pat Fashions Industries, Inc., et al., the debtors and debtors-in-possession (the "Debtors"), by their attorneys, Baer, Marks & Upham, for an order authorizing the sale of all of the Debtors' rights, title and interest in the Debtors' trademarks, set forth on Exhibit "A" (the "Trademarks"), annexed hereto; and upon the hearing held in connection therewith on October 12, 1994, and the record taken thereat, and after hearing all higher and better offers, if any, made for the Trademarks and it appearing that the sale of the Trademarks is in the best interest of the estates and their creditors, and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the Debtors be and they are hereby authorized and directed to sell the Trademarks, as set forth in Exhibit "A", free and clear of all liens, claims and encumbrances, if any, with valid liens, claims and encumbrances, if any, to attach to the proceeds of the sale; and it is further

ORDERED that the parties be and hereby are authorized and directed to execute any and all documents necessary to



effectuate the transfer and sale of the Trademarks; and it is further

ORDERED that the assignees of the Trademarks shall not be liable for any claims relating to the period prior to the date of the assignments herein; and it is further

ORDERED that Platzter, Fineberg & Swergold is hereby authorized and directed to release the monies it is holding in escrow on account of deposits or payments made with respect to the purchase of the Trademarks.
