ARDENT SOFTWARE, INC. (this "*Corporation*"), a corporation organized and existing under the laws of the State of Delaware, **DOES HEREBY CERTIFY THAT:**

(FIRST: This Corporation was incorporated on January 25, 1984 under the name of V-mark, Inc. and subsequently changed its name to VMARK Software, Inc., all pursuant to the General Corporation Law of the State of Delaware.

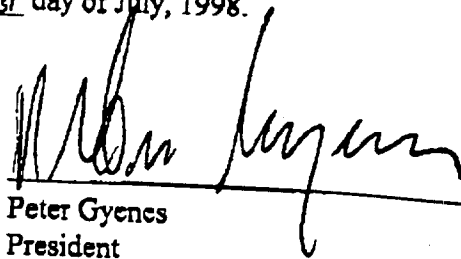
SECOND: This Corporation owns all of the outstanding shares of the common stock, \$.01 par value per share, of IntegraSoft, Inc., a Delaware corporation incorporated on July 12, 1996 pursuant to the laws of the General Corporation Law of the State of Delaware and having no class of stock outstanding other than said common stock.

THIRD: This Corporation, by the following vote of its Board of Directors, duly adopted at a meeting of the Board held on July 22, 1998, determined to, and effective upon the filing of this Certificate of Ownership and Merger with the Secretary of State of the State of Delaware does, merge IntegraSoft, Inc. into itself:

VOTED: That, effective upon the filing of an appropriate Certificate of Ownership and Merger embodying this vote with the Secretary of State of Delaware, IntegraSoft, Inc., a Delaware corporation and wholly-owned subsidiary of this Corporation, shall merge into this Corporation pursuant to the provisions of Section 253 of the Delaware General Corporation Law, and that the President of this Corporation is hereby authorized to make and execute, and the Secretary is hereby authorized to attest, a Certificate of Ownership and Merger setting forth a copy of this vote and the date of adoption hereof and to cause the same to be filed with the Secretary of State of the State of Delaware and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or appropriate to effect said merger.
