ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Assignment") is effective as of August 27, 1998 and executed by IVAX CORPORATION, a Florida corporation ("Assignor") and JOHNSON PRODUCTS COMPANY, a Florida corporation ("Johnson") for the benefit of FOOTHILL CAPITAL CORPORATION, a California corporation ("Agent") as collateral agent for Assignee (as defined in that certain Assignment Agreement dated as of the date hereof between Assignor, Agent and Assignee (the "Assignment Agreement")).

WHEREAS, Johnson owns all right, title and interest in and to the Pledged Collateral (as such term is defined hereinbelow);

WHEREAS, Johnson entered into that certain Johnson Intellectual Property Security Agreement dated as of July 14, 1998 (the "Security Agreement") in favor of Assignor;

WHEREAS, pursuant to the Security Agreement, Johnson pledged, assigned, transferred and granted to Assignor for Assignor's benefit, and Assignor accepted, a continuing first priority security interest in and to all of the right, title and interest of Johnson in, to and under the following property, whether existing as of the date of the Security Agreement or thereafter acquired (collectively, the "Pledged Collateral"):

a. patents issued or assigned to and all patent applications made by Johnson, including, without limitation, the patents and patent applications listed on Schedule A hereto, along with any and all (i) inventions and improvements described and claimed therein, (ii) reissues, divisions, continuations, extensions and continuations-in part thereof, (iii) income, royalties, damages, claims and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, and (iv) rights to sue for past, present and future infringements thereof (collectively, the "Patents");

b. trademarks (including service marks), federal and state trademark registrations and applications made by Johnson, common law trademarks and trade names owned by or assigned to Johnson and all registrations and applications for the foregoing, including, without limitation, the registrations and applications listed on Schedule B hereto, along with any and all (i) renewals thereof, (ii) income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages, claims and payments for past or future infringements thereof, and (iii) rights to sue for past, present and future infringements thereof (collectively, the "Trademarks");

c. copyrights owned by or assigned to Johnson, including, without limitation, the registrations and applications listed on Schedule C hereto, along with any and all (i) renewals and extensions thereof; (ii) income, royalties, damages, claims and payments now and hereafter due and/or payable to Johnson with respect thereto, including, without limitation, damages, claims and payments for past or future infringements thereof, and (iii) rights to sue for past, present and future infringements thereof (collectively, the "Copyrights");

d. license agreements and covenants not to sue with any other party with respect to any Patent, Trademark or Copyright listed in Schedule D hereto, along with any and all (i) renewals, extensions, supplements and continuations thereof, (ii) income, royalties, damages, claims and payments now and hereafter due and/or payable to Johnson with respect thereto, including, without limitation, damages and payments for past, present or future breaches thereof, (iii) rights to sue for past, present and future breaches thereof, and (iv) any other rights to use, exploit or practice any and all of the Patents, Trademarks or Copyrights (collectively, the "Licenses");

e. the entire goodwill of Johnson's business and other general intangibles, including, without limitation, know-how, trade secrets, customer lists, proprietary information, inventions, methods, procedures and formulae connected with the use of and symbolized by the Trademarks of Johnson; and

f. all "proceeds" (as such term is defined by the Uniform Commercial Code as in effect in any applicable jurisdiction in the United States and by other relevant law) of any of the foregoing,

in order to secure the payment, performance and observance of the obligations secured by the Security Agreement (the "Secured Obligations");

WHEREAS, pursuant to the Assignment Agreement, Assignor agreed to assign to Assignee the Secured Obligations, together with all collateral therefor, including but not limited to the Pledged Collateral; and

WHEREAS, pursuant to that certain Bill of Sale dated as of the date hereof, Assignor assigned to Assignee all right, title and interest in and to the Secured Obligations, together with all collateral therefor, including but not limited to the Pledged Collateral (collectively, the "Assigned Interest").






