Pursuant to the provisions of A.R.S. § 10-061, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

- FIRST: The name of the corporation is Sonic Air, Inc.
- SECOND: Article 1. of the articles of incorporation is hereby amended in its entirety to read as follows:  
  
The name of the corporation is SonicAir, Inc.
- THIRD: The amendment was adopted by the sole shareholder of the corporation on June 1, 1995, 1995, in the manner prescribed by A.R.S. § 10-059.
- FOURTH: The number of shares outstanding at the time of such adoption was 1,000 and the number of shares entitled to vote thereon was 1,000.
- FIFTH: The corporation has outstanding only a single class of stock.
- SIXTH: The number of shares voted for the amendment was 1,000 and the number of shares voted against the amendment was zero.
- SEVENTH: The amendment does not effect any exchange, reclassification, or cancellation of issued shares.
- EIGHTH: The amendment does not effect a change in the amount of stated capital.
