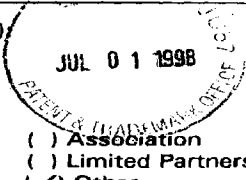

Furmanite Worldwide, Inc. for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.

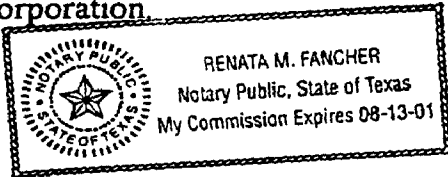

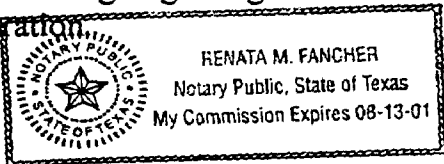
