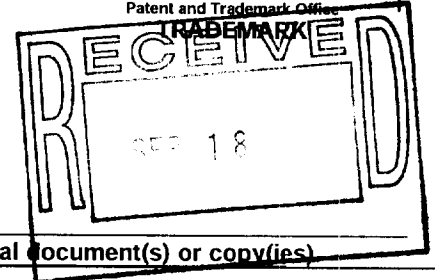

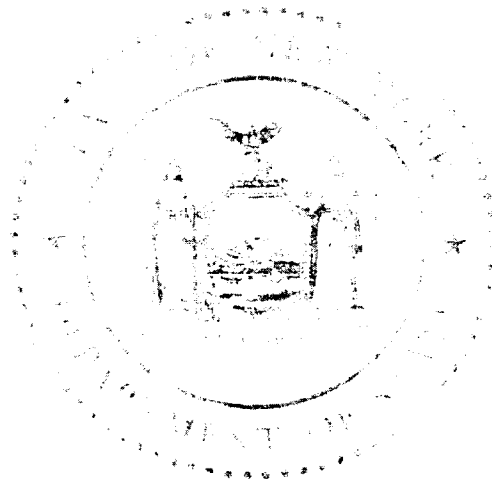

Product Intelligence, Inc."




