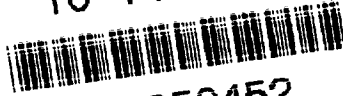

Pursuant to the provisions of Article 3.06 of the Texas Limited Liability Company Act and Article X of the Articles of Organization of Bismuth Cartridge, L.L.C., a Texas limited liability company (the "Company"), the Company adopts the following Articles of Amendment to its Articles of Organization, which amend Article I thereof so as to change the name of the Company.

Article II. The following amendment to the Articles of Incorporation was adopted by the members of the Company on April 15, 1998:

Article I of the Articles of Organization is hereby amended to read in its entirety as follows:

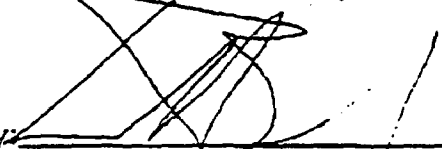
"ARTICLE I
