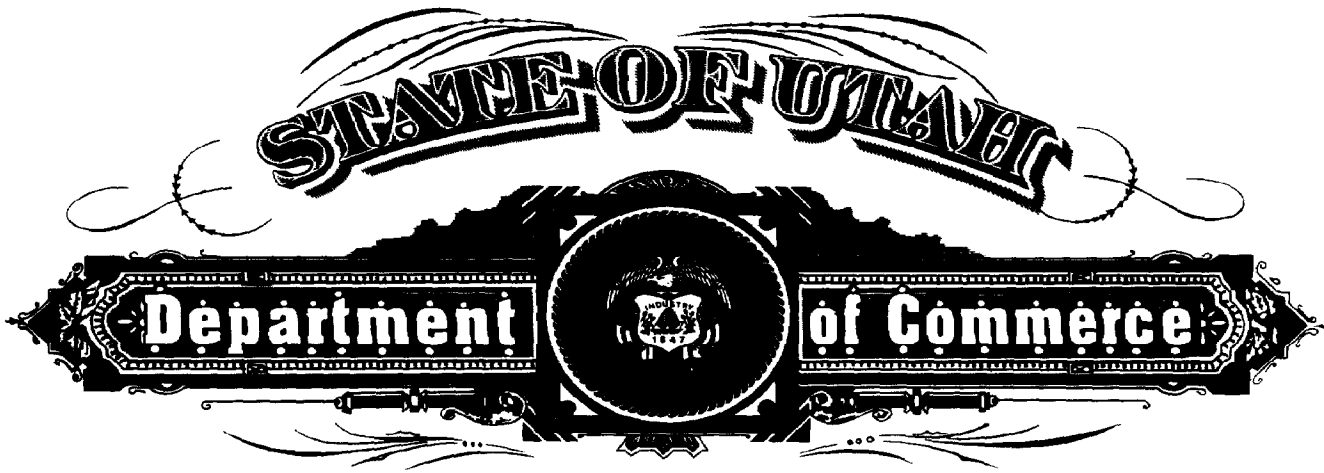

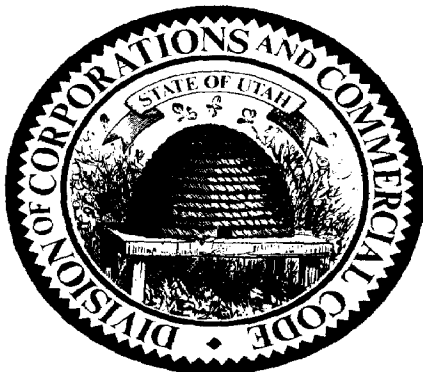

**To Be Effective 5:00 p.m. January 1, 1998**

The undersigned, R. Scott Newth being the Chief Financial and Operating Officer of teltrust.com, Inc., a Utah corporation (the "Company"), hereby certifies the following:



1. On October 27, 1997, the Board of Directors of Company approved, and recommended to the shareholders of the Company for their approval, a resolution to amend Article 1.1 of the Company's Articles of Incorporation in its entirety as follows:

1.1 Name. The name of this Corporation shall be "dotOne Corporation."

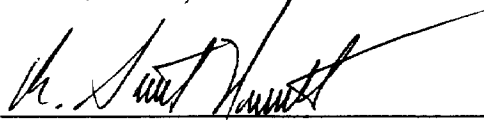

2. The Company has 85,268,080 shares of Common Stock and Series A Preferred Stock outstanding that were entitled to vote on the above resolution as a group. Each share of Common Stock is equal to one vote and each share of Series A Preferred Stock is equal to one-thirtieth of one vote. Pursuant to written consent, effective as of December 3, 1997, the holders of 83,008,977 shares of Common Stock and Series A Preferred Stock (constituting 67.05% of the votes cast), consented to the amendment as stated herein, and therefore, the number of shares voting in favor of the proposed amendment by each voting group entitled to vote thereon was sufficient for approval by that voting group.

4. These Articles of Amendment to the Articles of Incorporation shall, in accordance with Section 129 of the Utah Revised Business Corporation Act, become effective at 5:00 p.m. January 1, 1998.

IN WITNESS WHEREOF, the undersigned has executed these Articles of Amendment to the Amended and Restated Articles of Incorporation as of this 3rd day of December, 1997.
