RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Direct Subsidiary Trademark Security Agreement effective as of October 31, 1996 ("Trademark Security Agreement"), whereby The Bekins Company, a Delaware corporation located at 330 South Mannheim Road, Hillside, Illinois 60162 and LEP Profit International, Inc., a Delaware corporation located at 1950 Spectrum Circle, Marietta, Georgia 30067 (together, "Assignee") heretofore mortgaged, pledged and assigned to Banque Paribas, a French banking association located at 227 West Monroe Street, Chicago, Illinois 60606 ("the Assignor") for the ratable benefit of the Lenders identified in the Trademark Security Agreement a security interest in all of Assignee's rights, title and interest in, to and under the Secured Properties (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was duly recorded with the United States Patent and Trademark Office on December 10, 1996 at Reel 1537, Frame 0709, as amended by a Corrective Assignment, recorded on December 10, 1996, Reel 1574, Frame 0502; and

WHEREAS, the Assignor now desires to fully and completely terminate, release and discharge its entire security interest in, to and under the Secured Properties.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby fully and completely terminate, release and discharge the entire security interest which it now has or ever had from the beginning of the world to the effective date of this Release of Security Interest in Trademarks in, to and under the following (collectively, the "Secured Properties"):

- (i) each trademark, trademark registration and application for trademark registration, including, without limitation, each trademark and trademark registration referred to in Schedule "A" attached hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, as well as the right to sue for past infringement or dilution of any of the foregoing or for any injury to good will;
- (ii) each trademark license, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark license; and
- (iii) all proceeds of the foregoing, including, without limitation, any claims by the Grantor against third parties for past, present or future infringement or dilution of any trademark or trademark registration, or for injury to the goodwill of the business connected with the use of, or symbolized by, any trademark or trademark registration.

IN WITNESS WHEREOF, Assignor has caused this Release of Security Interest in Trademarks to be duly executed by its officer thereunto duly authorized effective as of the 31st day of December, 1997.
