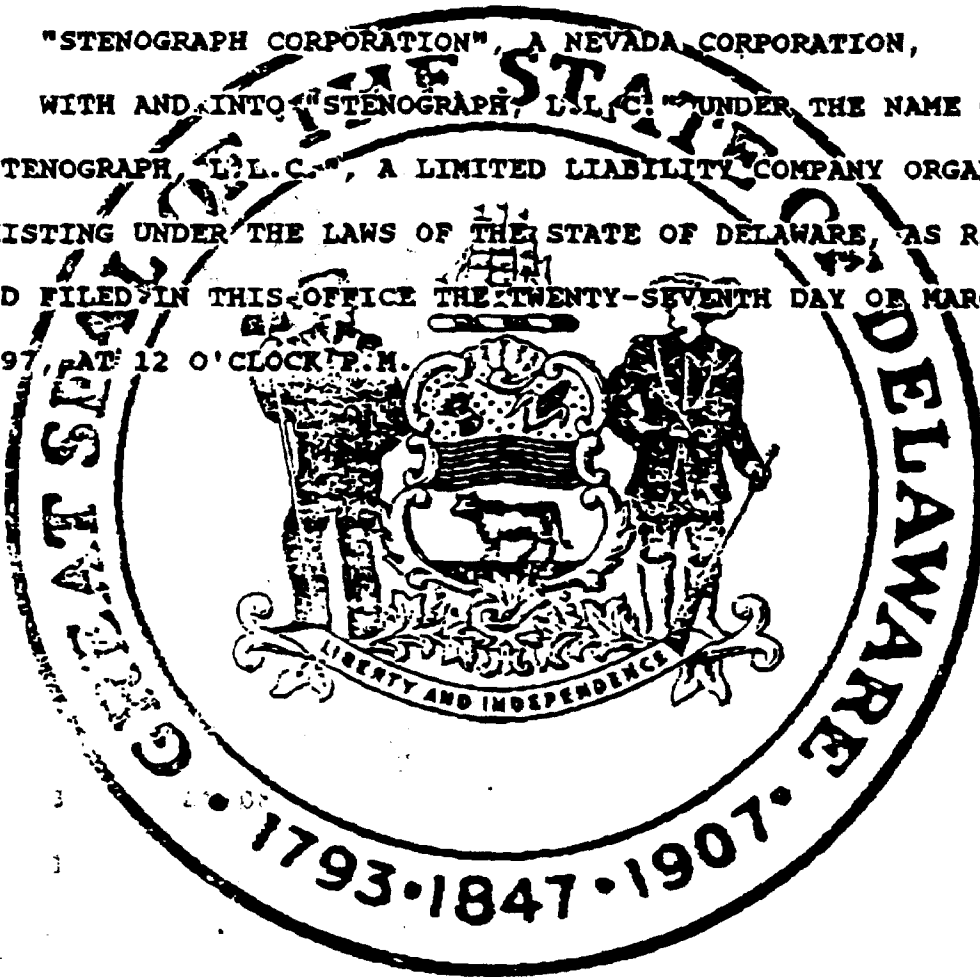

THIRD. The name of the surviving limited liability company is Stenograph, L.L.C., a Delaware limited liability company.

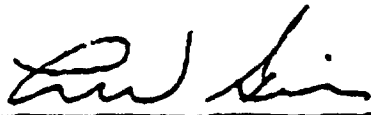
