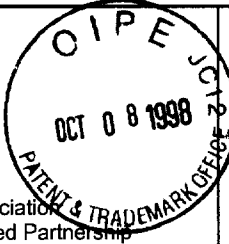

ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment") is made on this 23rd day of September, 1998 by and between Hahl Filaments Incorporated, a South Carolina corporation ("Assignor"), and Specialty Filaments, Inc., a Delaware corporation ("Assignee").

Background

The Assignor is the owner of the trademarks listed on Exhibit A attached to this Assignment (the "Trademarks"). The Assignor and the Assignee entered into that certain Agreement and Plan of Merger dated the date of this Assignment pursuant to which the Assignor merged into the Assignee (the "Merger Agreement"). As a consequence and by virtue of the merger effected by the Merger Agreement, the separate corporate existence of the Assignor ceased and the Assignee is the surviving corporation. The Assignor and the Assignee desire to effect the assignment of the Trademarks, together with all of the goodwill underlying such Trademarks to the Assignee. This Assignment is intended to be recorded in the United States Patent and Trademark Office.

IN CONSIDERATION of the foregoing and of the mutual promises, covenants and agreements contained in this Assignment, the Assignor and the Assignee, intending to be legally bound, hereby agree as follows:

1. Assignment of Trademarks. The Assignor hereby assigns to the Assignee all of the Assignor's right, title and interest in and to the Trademarks, together with all of the goodwill underlying such Trademarks, to the Assignee. The Assignee hereby accepts the foregoing assignment.
