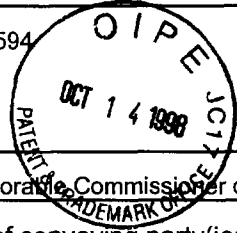


ASSIGNMENT
