ARTICLES OF AMENDMENT OF
CERTIFICATE OF INCORPORATION FOR JTM INDUSTRIES, INC.

JTM Industries, Inc. (the "Corporation") a corporation organized and existing under and by virtue of the laws of Texas, acting pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act does hereby execute these Articles of Amendment to the Articles of Incorporation of the Corporation.

FIRST: The name of the Corporation is JTM Industries, Inc.

SECOND: As of June 15, 1998, the following amendment to the Articles of Incorporation of the Corporation was unanimously adopted by the shareholders of the Corporation:

Article One of the Articles of Incorporation of the Corporation shall be deleted in its entirety and replaced with the following language:

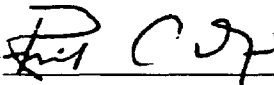
Article One

The name of the Corporation is ISG Resources, Inc.
