**ASSIGNMENT OF INTEREST**

**WHEREAS** Bell Sygma Inc., a corporation incorporated under the laws of Canada and having its registered office at Bell Trinity Square, 483 Bay Street, Floor 9 South Tower, Toronto, Ontario, M5G 2E1, Canada, from time to time also designated under its business name "Bell Global Solutions" ("Bell Sygma"), is the owner in Canada of the trade-marks listed in Schedule A attached hereto, in the United States of the trade-marks listed in Schedule B attached hereto, and in the European Community of the trade-marks listed in Schedule C attached hereto, and in other countries of the trade-marks listed in Schedule D attached hereto, collectively (the "Trade-Marks") and the applications and the registrations thereof; and

**WHEREAS** Bell Canada, a corporation incorporated under the laws of Canada and having its registered office at 1050 Beaver Hall Hill, Montreal, Quebec, H2Z 1S4, Canada ("Bell"), wishes to acquire the rights in Canada, the United States, the European Community and the other countries to the said Trade-marks, and the said applications and registrations thereof;


