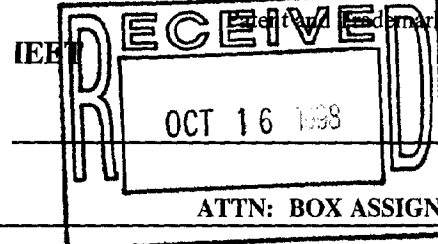

Pursuant to Section 242 of the Delaware
General Corporation Law

DMG USA, Inc., a Delaware corporation (the
"Corporation"), hereby certifies as follows:

FIRST: The Certificate of Incorporation of the
Corporation was filed in the office of the Secretary of State of
the State of Delaware on September 9, 1996 and a certified copy
was recorded in the Office of the New Castle County Recorder,
Delaware.

SECOND: The Certificate of Incorporation is amended
to change the name of the Corporation by striking paragraph FIRST
of the Certificate of Incorporation in its entirety and inserting
the following new paragraph FIRST as follows:
