RELEASE AND REASSIGNMENT
OF
TRADEMARKS AS SECURITY

WHEREAS, Freedom Textile Chemical Company (South Carolina), Inc., a Delaware corporation (the "Company"), owns the trademarks described in the attached Schedule A (the "Marks") for which there are recordings in the United States Patent and Trademark Office under the numbers set forth in the attached Schedule A; and


WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 15, 1995 (the "Agreement") the Company granted a security interest in, among other things, the Marks to secure the payment and performance by the Company of certain of its obligations; and

WHEREAS, the Agreement was recorded in the Assignment Branch, United States Patent and Trademark Office on January 11, 1996 located on Reel 1421, Frame 499-515.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Freedom Chemical Company does hereby terminate its security interest in, and reassign and reconvey to the Company, the Marks and (a) all renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (c) the right to sue for past, present and future infringements and dilutions thereof, (d) the goodwill of the Company's business connected with and symbolized by the Marks and (e) all of the Company's rights corresponding thereto throughout the world.
