ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, American Cyanamid Company, a Maine, United States of America corporation (hereinafter referred to as "ASSIGNOR"), has developed, conceived, acquired or otherwise owns certain intellectual property (hereinafter referred to as "ASSIGNED INTELLECTUAL PROPERTY") which includes: (a) the patents and patent applications (including, without limitation, all counterparts thereof in any other country and all reissues, divisions, continuations, continuations-in-part, renewals and extensions of the foregoing) (collectively, "Patents"), identified in Appendix A attached hereto, including the right to claim the benefit of any priority dates or provisional applications relating thereto under any applicable laws, and any renewal, substitute or reissue thereof, for the full term for which the same may be granted; (b) the registrations and applications for registration of the trademarks (collectively, "Trademarks"), identified in Appendix B attached hereto, and any associated goodwill incident thereto, including the right to use such Trademarks in regard to products and services in classes not yet utilized but relating to the business of ASSIGNOR; and (c) the trade secrets and confidential information (collectively, "Know-how"), identified in Appendix C attached hereto, to the extent to which the same is related to manufacturing.

WHEREAS, ASSIGNOR wishes to assign such ASSIGNED INTELLECTUAL PROPERTY to Tyco Group S.a.r.l., a Luxembourg corporation (hereinafter referred to as "ASSIGNEE"), and ASSIGNEE wishes to accept the assignment of such ASSIGNED INTELLECTUAL PROPERTY;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that effective for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby assigns and transfers to ASSIGNEE all right, title and interest of ASSIGNOR in and to said ASSIGNED INTELLECTUAL PROPERTY.

ASSIGNOR further covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.


