**DECLARATION REGARDING CORRECTION OF
PTO & DOCUMENT ERRORS IN DEED OF ASSIGNMENT**

ARMANDO DI NATALE declares as follows:

1. I am the President and Chief Executive Officer of ZANELLA LTD., located at 681 Fifth Avenue, New York, New York, and am duly authorized by ZANELLA LTD. to execute this document.
2. On or about May 20, 1997, ZANELLA LTD. filed a Deed of Assignment dated December 20, 1996 (Deed of Assignment) at the United States Patent and Trademark Office (PTO). The PTO recorded the Deed of Assignment at Reel No.1606, Frame No. 0790.
