**RELEASE AND TERMINATION  
OF INTELLECTUAL PROPERTY  
(TRADEMARKS - MECHANICAL PRODUCTS, INC.)**

KNOW ALL MEN BY THESE PRESENTS, that a certain Intellectual Property Security Agreement for trademarks (the "Intellectual Property Security Agreement-Trademarks") was executed by Mechanical Products, Inc., a Delaware corporation ("Debtor"), covering the Trademark Registrations and Trademark Applications more fully described on Schedule I annexed hereto and made a part hereof (the "Trademarks and Trademark Applications") in favor of Fleet National Bank, as Lender and as Administrative Agent for other Lenders (the "Agent"), dated as of March 31, 1998, and recorded with the United States Patent and Trademark Office on May 4, 1998 on Reel 1725 Frame 0827. 


