**ASSIGNMENT AND ACCEPTANCE

WHEREAS, the Corporate Commission of the Mille Lacs Band of Ojibwe Indians, a corporate body politic of the Mille Lacs Band of Ojibwe Indians, having an office and place of business at HCR 67, Box 194, Onamia, Minnesota 56359, hereinafter referred to as the "Commission," is desirous of acquiring the entire right, title and interest in and to the Marks, the U.S. Principal Registrations thereof, the common law rights to each service mark, and the goodwill and portion of the ongoing business pertaining thereto; and

WHEREAS, Grand Casinos is willing, pursuant to an agreement between the parties dated August 9, 1991 ("1991 Agreement"), to so assign all of its rights, title and interest in and to the Marks to the Commission;


NOW, THEREFORE, in consideration of the foregoing and in order to implement the terms of the 1991 Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and, without representation or warranty of any kind, express or implied, Grand Casinos hereby sells, assigns and transfers to the Commission, its successors and assigns, the entire right, title and interest in and to the Marks and the U.S. Principal Registrations thereof, the common law rights therein, the goodwill of the business pertaining to such marks, and the portion of the ongoing business pertaining to such marks. Nothing in this Assignment and Acceptance in any manner shall be deemed to supersede or terminate the 1991 Agreement, which Agreement shall remain fully in effect.

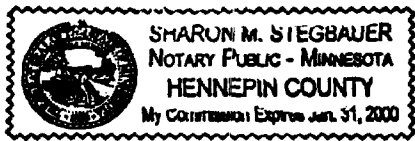
