

TRADEMARK ASSIGNMENT OF SECURITY

THIS ASSIGNMENT, made as of October 15, 1998, by Advertising Display Company, Inc., with an address at 1200 Valley Brook Avenue, Lyndhurst, New Jersey 07071 (the "Assignor") to Fleet Bank, National Association with an address at 208 Harristown Road, Glen Rock, New Jersey 07452 as agent (in such capacity, the "Agent") for the benefit of (i) the banks (collectively, the "Banks") named in the credit agreement of even date (together with all amendments, restatements, supplements and modifications, if any, from time to time made thereto, the "Credit Agreement") among the Assignor, the Banks and the Agent, and (ii) any Bank which is party to a Required Swap Contract as such term is defined in the Credit Agreement.

WHEREAS, pursuant to the Credit Agreement the Banks have, among other things extended commitments to make loans to Assignor; and

WHEREAS, it is a condition precedent to the obligation of the Banks to make loans under the Credit Agreement that Assignor enter into a certain security agreement, dated the date hereof, between Assignor and Agent (the "Security Agreement"); and

WHEREAS, Assignor has adopted, used and is using the marks shown on the attached Schedule A (the "Marks") for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown on the attached Schedule A.

WHEREAS, pursuant to the Security Agreement, Assignor is granting to Agent a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Agent and grant to Agent a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all of the Secured Obligations as defined in the Security Agreement and in accordance with the terms and provisions thereof.

Assignor expressly acknowledges and affirms that the rights and remedies of Agent with respect to the assignment and security interest granted hereby are more fully set forth in the Security Agreement.
