TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

This Termination of Patent and Trademark Security Agreement (this "Termination"), dated as of August 7, 1998, is executed by Greyrock Business Credit, a Division of NationsCredit Commercial Corporation ("GBC"), having its principal offices at 10880 Wilshire Boulevard, Suite 950, Los Angeles, CA 90024, in favor of Accugraph Corporation, a Texas corporation (the "Subsidiary"), which has a mailing address at 801 East Campbell Road, Suite 500 Richardson, Texas 75081 and Architel Systems Corporation, successor in interest by amalgamation to Accugraph Corporation, a corporation governed by the Canada Business Corporations Act (the "Parent Company"), which has a mailing address at 190 Attwell Drive, Suite 300, Toronto, Ontario M9W 6H8 CANADA.

RECITALS

WHEREAS, Subsidiary and Parent Company (collectively, the "Borrower") and GBC entered in a certain Loan and Security Agreement, dated as of January 9, 1998 (the "Loan Agreement"); and

WHEREAS, in connection with the Loan Agreement Borrower and GBC entered into a certain Patent and Trademark Security Agreement dated as of January 9, 1998 (the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, Borrower granted to GBC a security interest in certain "Collateral" including certain trademarks; and

WHEREAS, the Loan Agreement and the Security Agreement have been terminated.

NOW, THEREFORE, GBC agrees as follows:

1. GBC is executing and delivering this Termination as further evidence of the termination of the Security Agreement.
2. GBC claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Security Agreement, and, accordingly, GBC expressly terminates its security interest in the registered trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of the Security Agreement with the United States Patent and Trademark Office on February 17, 1998, in Reel/Frame 1697/0736.
