ASSIGNMENT FOR SECURITY

(TRADEMARKS)

Borrower does hereby further acknowledge and affirm that the rights and remedies of Bank with respect to the assignment of, security interest in and mortgage on the Trademarks made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
