

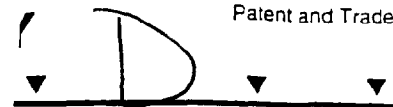

ASSIGNMENT OF TRADEMARKS AND TRADE NAMES

This Assignment of Trademarks and Trade Names (this "Assignment"), effective as of April 30, 1994, is from Teledyne Industries, Inc., a California corporation, with its principal offices at 1901 Avenue of the Stars, Suite 1800, Los Angeles, California 90067 ("Seller"), to Penn Union Corp., a Delaware corporation, with offices at 6140 Parkland Boulevard, Mayfield Heights, Ohio 44124 ("Buyer").

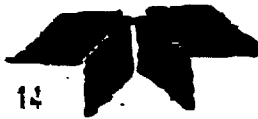
