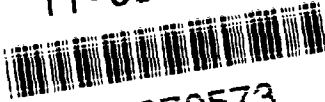



The commissioner of Patents and Trademarks is requested to file this Assignment as appropriate.


