TRADEMARK SECURITY AGREEMENT

This Notice of Amendment to Trademark Security Agreement dated as of September 30, 1998 (this "Notice"), is entered into between PROGRESSIVE INK COMPANY, LLC, a Delaware limited liability company (the "Grantor") and SOCIÉTÉ GÉNÉRALE, in its capacity as agent for the Lenders (in such capacity, the "Agent").
