WHEREAS, the Assignor is the owner of the trademark, the registration thereof (as shown on the attached Exhibit 1), and the good will of the business in connection therewith;


AND WHEREAS, the Assignee desires to acquire said trademark, the registration thereof, and the business and good will of the business in connection therewith.

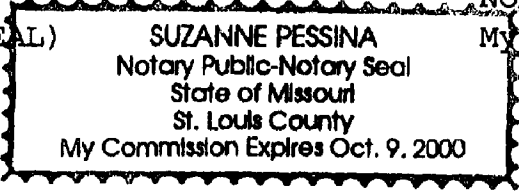
