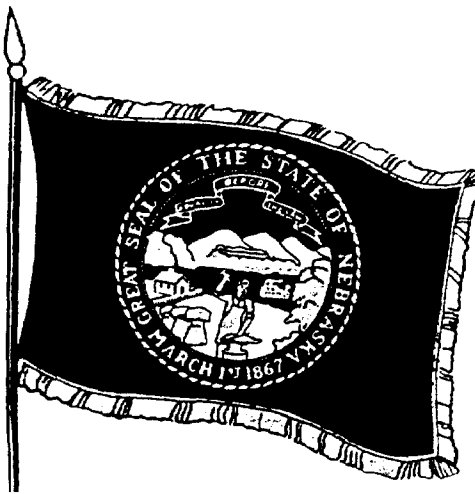

ARTICLES OF AMENDMENT

TO THE

ARTICLES OF INCORPORATION

OF

CENTURY MFG. CO.

Century Mfg. Co. (the "Corporation"), a corporation organized and existing under the laws of the State of Nebraska, does hereby adopt the following Articles of Amendment to its Articles of Incorporation pursuant to the Nebraska Business Corporation Act, §§ 21-2056 and 21-2060, and the Bylaws of the Corporation:

FIRST: The name of the Corporation is Century Mfg. Co.

SECOND: The following amendment of the Articles of Incorporation was adopted by the sole shareholder of the Corporation:

IT IS RESOLVED, that the Certificate of Incorporation of this Corporation be amended by changing the Article thereof numbered "Article 1" so that, as amended, the Article shall be and read as follows:

"The name of the Corporation is Arjo Manufacturing Company."

THIRD: The Sole Shareholder of Century Mfg. Co., Arjo, Inc., soon to be merged into Arjo USA, Inc., approved the resolution to amend the Articles of Incorporation on August 25, 1993.

FOURTH: This amendment to the Articles of Incorporation was adopted by unanimous written consent of all members of the Board of Directors and by consent of the Sole Shareholder.
