RELEASE OF SECURITY AGREEMENT - GENERAL INTANGIBLES
(PATENTS, TRADEMARKS, COPYRIGHTS, COMPUTER SOFTWARE)

This Release of Security Agreement - General Intangibles (Patents, Trademarks, Copyrights Computer Software) executed and effective as of October 22, 1998, relates to that certain Security Agreement - General Intangibles (Patents, Trademarks, Copyrights, Computer Software) entered into on October 28, 1997, (the "Security Agreement") by JERRY'S FAMOUS DELI, INC., a California corporation, (hereinafter, together with its successors and assigns, called the "Borrower") in favor of BANK OF AMERICA NATIONAL TRUST AND SAVINGS ASSOCIATION (the "Bank"), as party to the Business Loan Agreement dated as of October 28, 1997 between the Borrower and the Bank (as amended, the "Loan Agreement").

WHEREAS, pursuant to the Security Agreement, the Borrower granted a security interest to the Bank in certain trademarks described in the Security Agreement (the "Trademarks") as security for the Borrower's obligations to the Bank under the Loan Agreement; and

WHEREAS, the Security Agreement was recorded on December 23, 1997 with the United States Patent and Trademark Office in Washington, D.C. in Reel 1674, Frame 0094; and

WHEREAS, the Borrower has satisfied its obligations to the Bank under the Loan Agreement and has requested that the Bank release its security interest in the Trademarks and reassign the same to the Borrower.

NOW, THEREFORE, for good and valuable consideration, receipt and adequacy of which is hereby acknowledged, the Bank hereby agrees as follows:

1. The Borrower has satisfied all of its obligations under the Loan Agreement, the Loan Agreement has terminated, and the Bank hereby releases and forever discharges all mortgages, grants, sales, conveyances, transfers, settings over, and assignments of security interest granted under the Security Agreement in any and all of the Borrower's right, title or interest of every kind or nature in and to the following property:

(a) All pending trademarks, servicemarks, logos, and all United States, state and/or foreign applications for registration and registrations thereof, all trade names, trade styles, designs, and the like, all elements of package or trade dress of goods, the goodwill of the Borrower's business connected with the use of, and symbolized by any of the above, and all property of Borrower necessary to produce any products sold under any of the above, and other related property, all as more particularly described in the attached Exhibit A from the Security Agreement; and

(b) All rights to damages or profits due or accrued arising out of past, present or future infringement of the Collateral or injury to Borrower's good will connected with the use of the Collateral and the right to sue therefor.

(c) All renewals, modifications, amendments, re-issues, divisions, continuations in whole or part, and extensions of any Collateral.

(d) All proceeds of all of the foregoing.

2. The Security Agreement is hereby declared null and void and of no further force or effect.
