The undersigned Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is Jones/Rodolfo Corporation.
2. The Articles of Incorporation of the Corporation are hereby amended as follows:
  - a. Article I of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

ARTICLE I. NAME

The name of this corporation (the "Corporation") is Cutter & Buck Inc.

b. Article 9 of the Articles of Incorporation of the Corporation (regarding the initial registered agent and initial registered office) is hereby deleted.

c. The second sentence of Article 10 of the Articles of Incorporation of the Corporation (regarding the initial directors) is hereby deleted.

3. The foregoing amendments do not provide for an exchange, reclassification or cancellation of issued shares.

4. These amendments were adopted by the Board of Directors of the Corporation as of June 27, 1995. Shareholder action was not required pursuant to RCW 23B.10.020.

5. These Articles of Amendment shall be effective upon filing with the Washington Secretary of State.
