TRADEMARK ASSIGNMENT dated as of October 9, 1998 by **FIBERTRON CORPORATION**, a California corporation (the "Assignor"), in favor of **COMMUNICATIONS SUPPLY CORPORATION**, a Connecticut corporation (the "Assignee").

WHEREAS, Assignor, a corporation duly organized and existing under the laws of the State of California and having a principal business address at 6400 Artesia Boulevard, Buena Park, California 90620, is the owner of a certain trademark (and application therefor) identified in the attached Schedule A (the "Trademark") and all of the goodwill appertaining thereto; and

WHEREAS, the Trademark has been used by Assignor to identify Assignor as the source of those goods and services provided by Assignor through its business; and

WHEREAS, on this 9th day of October, 1998, Assignor has entered into that certain Asset Purchase Agreement (the "Asset Purchase Agreement"), pursuant to which Assignor has, as of the Effective Closing Time (as defined in the Asset Purchase Agreement), sold, assigned and transferred substantially all of its assets to the Assignee, a corporation duly organized and existing under the laws of the State of Connecticut and having a principal business address at 1401 Brook Drive, Downers Grove, Illinois 60515 (the "Assignee"); and

WHEREAS, in conjunction and connection with said sale, assignment and transfer of Assignor's assets to Assignee, Assignor has also sold all of its right, title and interest in and to the Trademark identified in the attached Schedule A to Assignee; and

WHEREAS, Assignor is desirous of confirming the sale, assignment and transfer of all of Assignor's right, title and interest in and to said Trademark and the goodwill symbolized thereby and accompanying therewith to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, effective as of October 1, 1998, the entire right, title, interest in and to the Trademark and the goodwill of that portion of Assignor's business connected with and appertaining to the Trademark, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.

Assignor further assigns to Assignee, effective as of October 1, 1998 all rights to sue for and receive all damages accruing from past infringements of the Trademark herein assigned.

This Assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.

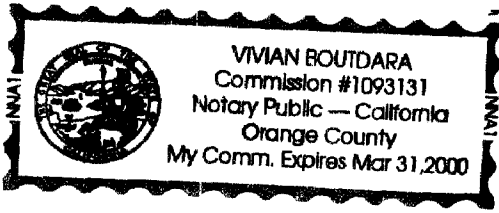
