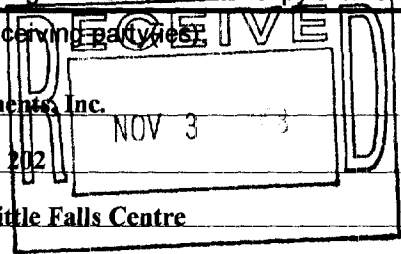

## TRADEMARK ASSIGNMENT
