**ASSIGNMENT OF TRADEMARK AND RELATED APPLICATION**

**THIS ASSIGNMENT OF TRADEMARK AND RELATED APPLICATION** (this "Assignment"), dated as of 21<sup>st</sup> October, 1998, is from GLAXO WELLCOME INC., a North Carolina corporation with an address of Five Moore Drive, Research Triangle Park, NC 27709 ("GW") to GLAXO GROUP LIMITED, a United Kingdom company with an address of Glaxo Wellcome House, Berkeley Avenue, Greenford, Middlesex UB6 0NN, United Kingdom ("GGL").

**RECITALS**

WHEREAS, the GW is the proprietor of the trademark RAX-PACK (the "Trademark"), and of related United States Trademark Application Serial No. 75/504,839 (the "Application"); and

WHEREAS, GGL desires to acquire the Trademark, the Application and the goodwill of the business symbolized by the Trademark from GW; and


WHEREAS, GW and GGL desire to confirm of record the assignment of the Trademark, the Application and the goodwill of the business symbolized by the Trademark to GGL;

NOW, THEREFORE, in consideration of the foregoing recitals (which are part of this Assignment), the mutual covenants and representations set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. GW hereby assigns to GGL all right, title and interest in and to the Trademark, together with (i) the Application, (ii) the goodwill of the business symbolized by the Trademark, and (iii) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Trademark.
2. GW further agrees to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as GGL may from time to time reasonably request to effect fully this Assignment and permit GGL to be duly recorded as the registered owner of the rights hereby conveyed.
3. Subject to the terms and conditions hereof, GGL hereby accepts the foregoing Assignment from GW.
