**SUMMARY RECORD OF TRANSFER OF
INTELLECTUAL PROPERTY ASSETS**

Pursuant to a corporate reorganization on April 1, 1998, all of the intellectual property assets (the Patent Rights and the Trademark Rights listed in Exhibit A) owned by ICO, Inc., a Texas Corporation, of which the undersigned was President, were transferred to a wholly-owned subsidiary corporation, ICO P&O, Inc., a Texas Corporation, of which the undersigned retained the title of President.

Further, on April 1, 1998, all of the intellectual property assets (the Patent Rights and the Trademark Rights listed in Exhibit A) of IPC P&O, Inc., a Texas Corporation, were transferred through another Texas Corporation formed by the merger of ICO P&O, Inc., with ICO Worldwide, Inc., a Texas Corporation to ICO P&O, Inc., a Delaware Corporation. The undersigned was retained as President of the merged Texas Corporations, ICO P&O, Inc. and ICO Worldwide, Inc.

ICO P&O, Inc., a Delaware Corporation, is the surviving corporate entity after a merger between ICO P&O, Inc., a Texas Corporation, and ICO P&O, Inc., a Delaware Corporation.

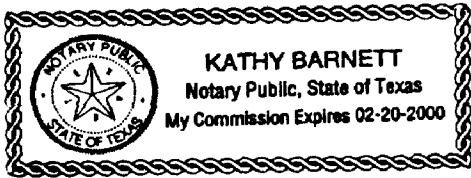
