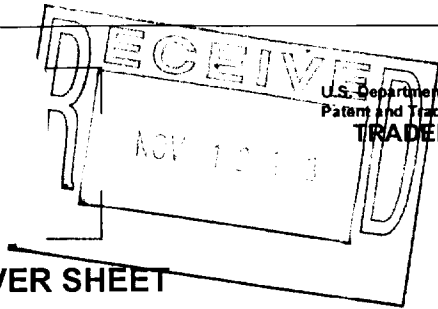

ASSIGNMENT

WHEREAS, the undersigned, Centocor, Inc., a Pennsylvania corporation, hereinafter referred to as Assignor, owns certain trademarks described on the attached Schedule A and the goodwill of the business associated therewith (collectively, the "Trademarks"); and

WHEREAS, CDP Holdings Corp., a Delaware corporation (formerly Gekko Holdings Corp.), hereinafter referred to as the Assignee, is desirous of acquiring the entire right, title and interest in and to the Trademarks.

After the execution of this Trademark Assignment, at the request of the Assignee and at the Assignee's expense, but without additional consideration to the Assignor, the Assignor will execute and deliver to the Assignee from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Trademarks, to perfect the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the Trademarks and to give full effect to this Trademark Assignment in the United States and worldwide.

This Trademark Assignment is binding on the Assignor and its respective successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.

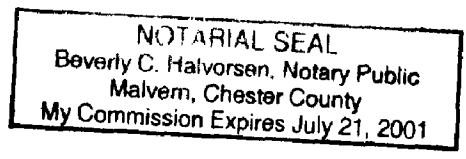
