ASSIGNMENT AND RELEASE

THIS ASSIGNMENT AND RELEASE is made by **COMPUMED, INC.** ("**Compumed**" having an address at Suite 1000, 1230 Rosecrans Avenue, Manhattan Beach, California 90266) and **BURDICK, INC.** ("**Burdick**" having an address at 500 Burdick Parkway, Deerfield, Wisconsin 53531) in favor of **GETZ BROS. & CO., INC.** ("**Getz**" having an address at 150 Post Street, Suite 500, San Francisco, California 94108-4750).

W I T N E S S E T H:

WHEREAS, The Burdick Corporation assigned all its right, title and interest in and to the mark **TELECOR** (U.S. Reg. 700,112), together with the goodwill of the business pertaining to the mark ("the Mark"), to Cordis Corporation on March 11, 1985, which assignment was recorded on May 13, 1985, at Reel 0494, Frame 0832 in the United States Patent and Trademark Office ("USPTO"); and

WHEREAS, Getz is the successor-in-interest to the Mark through a series of assignments originating with Cordis Corporation, all of which have been recorded in the United States Patent and Trademark Office; and

WHEREAS, The Burdick Corporation, through one or more name changes, is now known as Burdick, Inc.; and

WHEREAS, Burdick inadvertently "assigned" the Mark to Compumed on April 23, 1997, which document was recorded on May 19, 1997 in the PTO at Reel 1590, Frame 0634; and

WHEREAS, Burdick and Compumed realize that the April 23, 1997 assignment of the Mark to Compumed was an error, inadvertent, and without effect because of the earlier recorded Assignment in favor of Cordis Corporation.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) paid by Getz jointly to Burdick and Compumed and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, Compumed and Burdick jointly and severally hereby:

- (i) acknowledge that the assignment from The Burdick Corporation to Cordis Corporation, dated April 11, 1985, fully assigned all rights in and to the Mark to Cordis Corporation;
- (ii) agree that the assignment dated April 23, 1997 of the Mark from Burdick to Compumed was in error, inadvertent and without any legal effect;
- (iii) disclaim and release any and all rights in the Mark;

- (iv) represent and warrant that they shall not assert any rights in and to the Mark; and
- (v) assign and transfer to Getz any rights in the Mark and registration, together with all goodwill associated herewith, which may be attributed to or asserted by or on behalf of Burdick or Compumed.

Compumed does not acknowledge by this document that it has used the Mark on any product, and Compumed specifically states that this document is not an acknowledgement of any use of the Mark.

Burdick shall indemnify, defend and hold Compumed harmless against all claims, including all costs, expenses, damages and reasonable attorneys fees, arising from alleged unauthorized use of the Mark by Compumed.

This Assignment and Release is executed by the undersigned duly authorized officers of the parties.
