**RELEASE OF TRADEMARK AND LICENSE SECURITY INTEREST**

**WHEREAS**, pursuant to the Amended and Restated Conditional Assignment of and Grant of Security Interest in Intellectual Property Rights (Trademarks) dated as of March 31, 1995, and filed with the United States Patent and Trademark Office at Reel 1331, Frame 0125 of the Trademark Record (the "Security Document"), Creditanstalt AG (f/k/a Creditanstalt-Bankverein), as Collateral Agent (the "Secured Party") became the holder of a security interest and conditional assignment in and to all of the right, title and interest in, under or by virtue of certain trademarks, service marks, licenses and other intangible assets owned by Prince Castle, Inc., a Delaware corporation (the "Debtor"), as set forth in Exhibit A hereto (the "Collateral").
