

Pursuant to Section 251 of the General Corporation Law of the State of Delaware (the "DGCL"), Desktop Data, Inc. a Delaware corporation, hereby certifies as set forth below:

FIRST: That the name and state of incorporation of each of the constituent corporations in the merger are as follows:

SECOND: An Agreement and Plan of Merger and Reorganization dated as of November 2, 1997, between Desktop Data, Inc. and Individual, Inc. (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 251 of the DGCL.

THIRD: The name of the surviving corporation is Desktop Data, Inc., whose name is hereby changed to NewsEDGE Corporation (the "Surviving Corporation").
