

WHEREAS prior to October 6, 1995 Chemical New Jersey Holdings, Inc. ("CNJH") adopted, owned and began using the mark "HORIZON" (the "Mark") in connection with banking services;

WHEREAS the Mark is registered on the Principal Register of the United States Patent and Trademark Office in connection with banking services, under Registration No. 1,362,420, registered on September 24, 1985;

WHEREAS as of October 6, 1995 the outstanding capital stock of CNJH was transferred by its parent, Chemical Banking Corporation ("Assignee"), a Delaware corporation with its principal place of business located at 270 Park Avenue, New York, New York 10017, to PNC Bank Corp. ("Assignor"), a Pennsylvania corporation with its principal place of business located at One PNC Plaza, Pittsburgh, Pennsylvania 15265, pursuant to a Stock Purchase Agreement between Assignee and Assignor dated March 7, 1995, under which Assignee retained all rights to own and use the Mark in connection with banking services;

WHEREAS since October 6, 1995, consistent with the Stock Purchase Agreement, Assignee has continued to use the Mark in connection with banking services;

WHEREAS on December 12, 1995 CNJH was merged into Assignor;

WHEREAS on March 31, 1996 Assignee changed its name to The Chase Manhattan Corporation, in connection with the merger into Assignee of the entity then known by that name; and

WHEREAS Assignee and Assignor desire to confirm Assignee's ownership of the Mark and the above-referenced registration as contemplated in the Stock Purchase Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, together with the registration thereof, nunc pro tunc, effective as of October 6, 1995.
