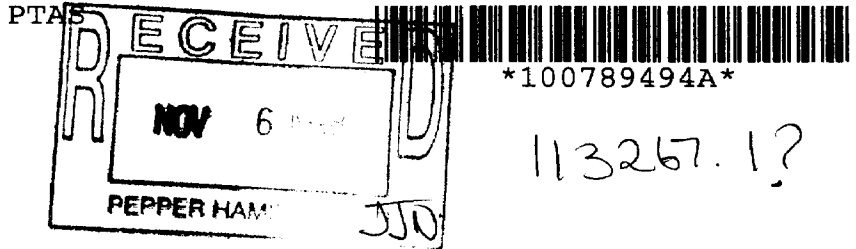

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated under the name SP-Sub, Inc. on the 13th day of October 1981 and its name was changed to Kent-Moore Corporation on February 1, 1982.

SECOND: That this corporation owns all of the outstanding shares of the capital stock of each of the following corporations:

- (a) Kent-Moore Stamping and Fabricating Co., a corporation incorporated on the 15th day of February, 1920 pursuant to the Law of the State of Michigan.
- (b) Maynard Manufacturing Co., a corporation incorporated on the 17th day of September, 1964 under Public Act 327 of 1931 of the Laws of the State of Michigan.
- (c) Norbrook, Inc., a corporation incorporated on the 19th day of April 1978 under Public Act 284 of 1972 of the Laws of the State of Michigan.
- (d) Pyles Industries, Inc., a corporation incorporated on the 1st day of May, 1947 under Public Act 327 of 1931 of the Laws of the State of Michigan.
- (e) Standard Composite Die Company, a corporation incorporated on the 1st day of February, 1960 under Public Act 327 of 1931 of the Laws of the State of Michigan.
- (f) Robinair Manufacturing Company, a corporation incorporated on the 12th day of January, 1956 under Title 17 of the Ohio Revised Code of the Laws of the State of Ohio.

THIRD: That this corporation, by the following resolutions of its board of directors, duly adopted by the unanimous written consent of its members dated the 14th day of December, 1982, and filed with the minutes of the Board, determined to and did merge into itself each of the following corporations:

FURTHER RESOLVED, that the merger of each of said corporations into Kent-Moore Corporation shall become effective at midnight on December 31, 1982, and

FURTHER RESOLVED, that the proper officers of this corporation be and they hereby are directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge each of the said Kent-Moore Stamping and Fabricating Co., Maynard Manufacturing Co., Norbrook, Inc., Pyles Industries, Inc., Standard Composite Die Company and Robinair Manufacturing Company into itself and to assume all of their respective liabilities and obligations, and the date of the adoption thereof, and to cause the same to be filed with the Secretary of State of Delaware and a certified copy recorded in the office of the Recorder of Deeds of New Castle County, Delaware, and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in anywise necessary or proper to effect said merger.
